

ONE: The legal resitered name of this corporation is The Press Institute for Women in the Developing World. On January 30, 2011 the Board of Directors adopted a resolution to operate under the legal DBA Global Press Institute. The DBA was registered pursuant to the regulations on Feburary 1, 2011. On January 7, 2013 the Board of Directors adopted a resolution to formally change the name of the organization to Global Press Institute.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes. The specific purposes for which this corporation is organized are to provide journalistic training and long term employment to women in the developing world.

THREE: The State of California of this corporation's initial agent for service of process is Cristi Hegranes.

FOUR: (a) This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

(c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any

candidate for public office.
