Successful completion of the training, and therefore successful use of the grant funds, must occur within one calendar year. Approximately 96% of trainees achieve a successful completion. Post-training, graduates may receive reporting grants to produce news coverage from their communities, implementing the skills learned in the training. Reporting grants are made based on pitches (proposals) for specific stories. Grants are evaluated based on the successful completion of each story for which payment was made. Nearly 100% of reporting grants resulted in accompanying coverage.
