Post-training, graduates may receive reporting grants to produce news coverage from their communities, implementing the skills learned in the training. Reporting grants are made based on proposals for specific stories. Grants are evaluated based on successful completion of each story for which payment was made. Nearly 100% of reporting grants resulted in accompanying coverage.
